The company that prepared the audit report and the assigned experts did not take part in the establishment and training of ETİ SODA Modern Slavery prevention policies, management systems. They have carried out an objective and independent assessment.

The GAP analysis team was composed of lead auditors, lawyers (labor law) health, safety and wellbeing proffesionals experienced in industrial sector, and trained in a range of sustainability, legal regulations, quality, health and safety, environmental and social standards including ISO 9001, ISO 14001, ISO 45001, ISO 45003, ISO 27001 etc.

With regard to the visit held on 20-21.03.2023, ETİ SODA A.Ş.'s policies on Combating Modern Slavery and Human Trafficking, company practices, field studies and application records were examined. Considering the interviews with managers, employees, interns, subcontractors, reviewed records, feedback, suspicious situation determination studies, and reporting policies, it was determined that there were no officially recorded modern slavery and human trafficking cases in the company. The company has provided all necessary preparations to prevent Modern Slavery and Human Trafficking with its current policies and practices. In order to continuously improve the existing policies and system, the company has included the top management, all employees and the supply chain in the process, and included the targets aimed at preventing modern slavery and human trafficking in the 2023 targets.

This reporting has been prepared at the request of ETİ SODA and has been prepared in order to provide an independent assessment of the current situation practices. Reporting covers only Eti Soda policies, activities and practices and does not cover the Supply Chain.
